
### JOHN & JOANNE MAITLAND, HONORARY CHAIRS

2003 was an exciting time as our new school was



# With the faith of a mustard seed ... (Matthew 17:20)

# 1863

Our ancestors in faith purchased another church building and moved it to Main and Olive and dedicated it to the Lord in June.

# 1858

The Rev. Friedrich Ruff and Trinity Lutheran began in the old McLean County Court House. Our rich school tradition began as well with classes held during the week taught by Trinity's first three pastors

# 1955

Our new unified church and school building dedicated in February 1955.



# 1958

We celebrated a century of faith in our Trinity Lutheran family.

# 1884

By the early 1880s the congregation had outgrown its church. The members of Trinity Lutheran built a beautiful new sanctuary again at Main and Olive Streets.



# 1892

Both schools were consolidated and a new school was constructed on our current (South Madison St.) site.



# 1867

The congregation was officially received as a member of the German Evangelical Lutheran Synod, which is known today as the Lutheran Church–Missouri Synod.

Trinity continued to add to its membership and the school grew to over 100 pupils by the early 1870s. This precipitated Trinity Lutheran to build two schools in 1873, one located on the south side of Bloomington at Lincoln and Main Streets, and one located on the west side of Bloomington on W. Chestnut St.

# 1941

By the mid-'30s, the congregation realized the need for a parish hall and improved school facilities on our current (South Madison) and both were completed in March 1941.



2003

We replaced our 60-year-old school with a new facility on our Hamilton Road property. We also made some improvements to our current church site with a new covered drop area, elevator, and better lighting.

# 2008

Trinity Lutheran celebrated its 150th year serving the people of Bloomington, IL and the surrounding communities. By God's grace, we continue to serve!



# 2017

The congregation votes to build a new sanctuary on the Hamilton Road campus and re-unite with our school.

# Dur Meed

S ince our school opened on Hamilton Road in 2003, our resources have been divided between two campuses. This division limits our community's chance to collaborate as a staff and faith family. Additionally, our students miss out on the gift of chapel held in an actual sanctuary. School families without a worship home currently do not have the opportunity to witness our great work as a faith family every day. Unifying the school and church will improve our entire community and better support our students.


As our ministries have adapted to a changing culture, our current facilities have not. We have a growing need for larger gathering space, for a nursery, cry room, and nursing space that better supports young families in worship, and bathrooms more accessibly located on the main level. The new facilities will be warm and welcoming for many generations. Our current sanctuary home has given us so many memorable moments for our family in Christ. However, it is now time for us to build a new church home for future generations.

# PHASE 1

Will give us the space to accommodate about 750 people in worship and allow us to continue to offer three Sunday services. An expanded fellowship space with new, larger meeting areas and a café will enable us to grow as a family in Christ. Modern communication tools, state-of-the-art audio and video capabilities, and well-designed acoustics will be in our new home. Our unified church and school staff will have the power to advance our mission with new and expanded administrative space. Plenty of convenient parking will be available as we will be able to accommodate over 250 vehicles. Finally, we have prepared for continued growth in our new sanctuary by designing a structure that can accommodate a new balcony when the time comes for that need.

Galatians 3:28 tells us that: "...you are all one in Christ." So now we look forward to constructing a church home where all are welcome. Our sanctuary will be a place where we can find respite from the challenges found in the world today and a place where we can come together in Christ to better equip ourselves to carry out the Great Commission of bringing the good news of Jesus Christ to all the world. As we are told in Matthew 9:37 "...the harvest is plentiful, but the laborers are few."

It will truly be a sanctuary where we can find strength to battle the troubles of this world, where many memories as a faith family will be made, and where our wonderful faith tradition will continue.



# Methods of Giving
